The board of directors (“**Board**”) of Lai Sun Development Company Limited (“**Company**”) announces that all the resolutions (“**AGM Resolutions**”) set out in the notice of the annual general meeting of the Company (“**AGM**”) dated 12 November 2015 (“**AGM Notice**”) were duly passed as ordinary resolutions by way of poll at the AGM held on Friday, 11 December 2015 at 11:00 a.m.
